

ARE ALL FUNCTIONAL APPLIANCE TREATMENTS CREATED EQUAL?

The protocol of fixed functional treatment appliance for 25 years will be presented. Research of treated cases will validate the protocol producing dentofacial orthopedics with minimal tooth movement. A new appliance, AdvancSync, will be shown which allows Class II treatment in Class I time. Step-by-step use of the AdvanSync Appliance will be discussed.

1. Evidence-based protocol to produce dentofacial orthopedics for Class II correction.
2. How to correct Class II malocclusion while simultaneously rendering Class I orthodontic mechanics. Class II in Class I time.
3. Step-by-step treatment plan from 25 years' clinical experience of orthopedic correction of Class II malocclusions.
4. Have we been fixated too long in orthodontics on "growing mandibles"?

Long-term cases will be shown. Also mixed dentition research along with mixed dentition cases will also be shown. Adult Herbst treatment will also be described.
